2. A contestant may submit up to three entries and must complete the above entry form for each submission.
3. The deadline for submission is 5:00 PM on Sunday, January 1<sup>st</sup>, 2023.
4. PPA reserves the right to extend all deadlines associated with the Contest.
5. App name ideas that are already in use will be disqualified.
6. Contestants agree to assign all ownership rights, including all intellectual property rights and associated goodwill in the submission(s), to PPA. Further, PPA may alter, modify or revise the submission(s) as the PPA sees fit in its sole discretion. .
7. The PPA reserves the right to reject any submission or disqualify any contestant for offensive or inappropriate materials.
8. PPA will choose a winner on Friday, January 6th, 2023.
9. The winning contestant will be awarded one of the following:
  - If the winning contestant is a current monthly patron, they will receive one (1) month of complimentary parking at the PPA-operated garage they hold a monthly account with excluding Gateway Garage.
  - If the winning contestant is a non-monthly patron, they will receive a voucher for 100 hours of complimentary parking at a PPA-operated garage of their choice with the exception of Gateway Garage. A minimum of six (6) hours will need to be utilized per parking session
