NOTICE TO BIDDERS

The Authority is seeking qualified contractors to furnish a new sprinkler and fire alarm system at the Autopark at Independence Mall (“IMG”), as well as the installation of a new fire alarm system at the Parkade on 8th Parking garage.

Sealed bids will be received until **12:00 PM on Tuesday, April 2, 2024**, by the Philadelphia Parking Authority (“Authority”), a body corporate and politic created under the laws of the Commonwealth of Pennsylvania in accordance with the Act of June 19, 2001, P.L. 287, No. 22, as amended, known as the “Parking Authority Law,” in the offices of the Authority, located at 701 Market Street, Suite 5400, Philadelphia, PA 19106.

Prospective Bidders are required to register for the solicitation using the [Bidder Registration Form](#) (control-click to access the form) prior to the Pre-Bid meeting on March 7, 2024. Bid Documents will be made available through a [Dropbox link](#), the link will be sent to the email address provided on the Bidder Registration Form.

Prospective Bidders are required to attend a mandatory Pre-Bid Meeting that will be held at the Autopark at IMG located at 41 N. 6th Street, Philadelphia, PA 19106 on **Thursday, March 7, 2024 at 11:00 AM. Please use the entrance on the 6th street side of the Visitor Center, located in the middle of the block.**

Mandatory site visits will take place immediately following the Pre-Bid Meeting, at IMG and Parkade on 8th. Please allow for adequate time when attending the Pre-Bid Meeting. Attendance will be taken at both locations and is required.
