PETITION FOR RATE CHANGE

I Petitioner, Ronald Blount as a certified PPA-TLD taxicab driver and as president of the Taxi Workers Alliance of Pennsylvania, and under the authority granted in 52 Pa. Code § 1005.21, hereby request a Change in Rates pursuant to 53 Pa. C.S. § 5703 and avers as follows:

- 1. Petitioner is a certified PPA-TLD taxicab driver under license number H-102361.
- 2. Petitioner request that the Authority re-establish the current tariff to include up-front pricing or pricing to allow approved PPA app-based providers and Philadelphia medallion taxicabs to calculate their own fare outside of the taximeter but must provide passengers with a binding up-front fare quote to offer taxi passengers the same price certainty as Transportation Network Companies (TNC). The implementation of up-front pricing will offer guaranteed up-front fares to passenger prior to booking a trip. This level of price certainty is attractive to passengers and allows them to comparison shop, a competitive advantage that Philadelphia medallion taxicabs can't leverage under current PPA requirements. Philadelphia medallion taxicabs drivers will receive a fare offer on the driver information monitor installed in every taxicab. The fare offer must include, at a minimum, the pickup location and the flat net dollar amount the driver will earn. Unlike street-hails, which calculate a running fare total during the trip, these fares are determined prior to the driver accepting the trip. Up-front trips are not mandatory, and drivers

may refuse to accept the fare offer, however drivers will have the ability to better compete with TNC's in a post-COVID-19 market on an experimental basis.

- 3. Petitioner seeks to amend this request to include an increase in the Airport flat rate from \$28.50 to \$32.00. Petitioner further request that the minimum fare from the Airport increase from \$11.00 to \$20.00. Both of these amendments will offset the reduction in fares, escalating fuel and consumer prices, and the rising cost of vehicle maintenance.
- 4, § 1003.11. Petitions for issuance of emergency orders.
- (a) To the

extent practicable, a petition for emergency order must be in the form of a petition as set forth in § 1005.21 (relating to petitions generally) and shall be served on the persons directly affected by the application.

- (b) A petition for emergency order must be supported by a verified statement of facts w hich establishes the existence of an emergency, including facts to support the following:
- (1) The petitioner's right to relief is clear.
- (2) The need for relief is immediate.
- (3) The injury would be irreparable if relief is not granted.
- (4) The relief requested is not injurious to the public interest
- 5. § 1030.2. Taxicab rates and tariffs. (a) Medallion taxicabs. All medallion taxicabs shall offer a guaranteed up-front pricing to passengers prior to booking a trip through an approved PPA app as determined and approved by the Authority upon investigation as provided in section 5703 or 5720 of the act, or both (relating to rates; wages).
- (2) Flexible Rates and Surcharges. A certificate holder or certified driver may petition the Authority to reopen a rate investigation under section 5703 or 5720 of the act, or both

(relating to rates; wages) to allow for flexible rates or surcharges, including fuel or peakhour surcharges. (i) Any request for a flexible pricing model shall include a proposed framework for consumer protections that involve upfront disclosure of the fare in a way that is not contingent upon consumer request and such flexible pricing model will be computed to not violate the Price Gouging Act, 73 P.S. §§ 232.1, et seq. (3) Any approved flexible pricing model or surcharge shall be reviewed annually by the Authority.

(b) Dispatchers. (1) Upon advanced written notice to the Authority, a dispatcher certificate holder may offer below-tariff pricing such as coupons, loyalty programs and corporate client discounts. (2) Upon approval by the Authority from a written request by a dispatcher certificate holder, a dispatcher may establish procedures for assessing fees to passengers for any of the following: (i) Cancellation of prearranged taxicab service within a certain time period of when the requested service was scheduled to begin; (ii)

Nonappearance of a passenger after requesting prearranged taxicab service; or (iii)

- 6. Pursuant to 53 Pa. C.S. § 5703, Petitioner further request that the Authority implement Interim emergency relief as Petitioner has outlined in the "Petition For Interim Emergency Relief" Form.
- 7. On November 4, 2016, the Governor signed Act 164, since then, taxicab drivers and owners have

lost 70% of their income.

8. The Authority is aware of the declining number of taxicab medallions in voluntary

suspension, Petitioner estimates that over 1000 taxl medallions are incapacitated.

9. The number of active certified taxicab drivers have decreased from 5,000 in 2014 to about

300 today.

10. Over 10,000 TNC vehicles are now actively working in Philadelphia, grabbing the

lion-share of revenues.

11. Petitioner request the proposed up-front flexible fare change go into effect immediately

upon the approval of the present Petition and that it applies to all taxicabs pursuant to 53 Pa.

C.S. § 5720(b).

12. Pursuant to 53 Pa. C.S. § 5703, this Petition will help taxicab drivers achieve a fair

return for their labor and expenses, will be non-discriminatory to any person, Just and

reasonable, and conforms with the Authority's statutes and regulations.

13. Granting the present Petition will alleviate the harm incurred by taxi drivers by

permitting them to recover some of the lost revenues.

14. Petitioner

Petitioner request that the Authority grant this Petition to help stabilize the declining income

of taxicab drivers and to ensure that taxicab medallion owners can receive the leasing fees for

their medallions. Petitioner states that the above request will not harm the public and will

be able to prove If deem necessary.
