CHANGES TO THE RFP DOCUMENT

1. Appendix D of the RFP Document: Appendix D has been revised. Please see Appendix A of this addendum.

QUESTIONS

1. Question: What is the current rate of revenue share?

Response: The current rate of revenue share is 18% of gross sales per machine.

2. Question: How many employees are located at each site and how many visitors are on site each day on average?

Response: Please see Appendix A of this addendum.

3. Question: Could we please have the vending sales per machine per year for 2024 and the sales per machine for January to June 2025?

Response: The available sales data can be found in Appendix B of this addendum.

4. Question: Could we please have photos of each vending area?

Response: Yes, please see Appendix C of this addendum.

5. Question: Can we calculate sales by first deducting the Philadelphia sales tax, and Philadelphia Sweet Beverage Tax amounts, before applying the revenue share rate?

Response: Yes, Offerors must indicate in their proposal if the revenue share will be applied to gross sales or net sales.

6. Question: What are the vending prices for chips, candy, pastry, cookies 20 oz soda, bottled water, sports drink, energy drink, juice?

Response: Chips \$2.10. candy \$2.60, pastry \$2.60, cookies \$2.60, soda \$2.85, Water \$2.60, Juice \$2.80, energy drink \$4.60.

7. Question: Are all vending machines at each Authority location cashless?

Response: No, all vending machines have a cash option.

8. Question: Would the Authority like to continue to accept cash as a form of payment for vending purchases?

Response: Yes, please see RFP document Part IV-2, 4. Technology and Payment Systems.

9. Question: Regarding service requests, is the four-hour acknowledgement time during normal business hours?

Response: Offeror must respond to a request within 4 hours and be on-site within 24 hours, during normal business hours, Monday-Friday 8:00 AM to 5:00 PM. Please see RFP document Part IV-2, 6.B. Service Request.

10. Question: Does the Authority have any 24-hour lots?

Response: Yes, the Authority has 3 impoundment lots that are 24 hours, Lot 1, 6, and 7.

11. Question: Is the revenue shared by gross sales?

Response: Yes.

12. Question: Will there be a deduction for the Philadelphia soda tax or sales tax before we apply commission rate?

Response: Please see response to Question 5.

13. Question: Would the Authority accept a revenue sharing structure less the soda and sales tax?

Response: Please see response to Question 5.

14. Question: Is it possible to see the locations where the current vending machines are installed?

Response: Yes, please submit a question using the Question Submission Form identifying which Authority locations you would like to see.

15. Question: Can we see the vending machines that are located here at the Authority Headquarters, 701 Market Street?

Response: Due to some Offerors attending the Pre-Proposal meeting virtually a site visit must be scheduled to present the opportunity to all Offerors.

16. Question: Are the Authority's current vending machines located outdoor and indoor?

Response: Vending machines are located indoors.

17. Question: Is there electricity in the Authority locations that currently have no vending machines?

Response: No, however, the Authority will provide electric at all locations.

18. Question: How many employees and how much foot traffic is there at each Authority location with vending machines?

Response: Please see Appendix A of this addendum.

19. Question: Is there a breakdown between soda and food machines which are shelf stable snacks versus actual fresh food?

Response: The Authority currently only has one vending machine that offers fresh food which is indicated in Appendix A of this addendum.

20. Question: Does the Authority's Airport vending machines contain fresh food?

Response: Yes.

21. Question: How much revenue is being generated through the current vending machines?

Response: Please see Appendix B of this addendum.

22. Question: Is the Authority's Airport vending machine a turnstile?

Response: Yes.

23. Question: Will the Authority identify which locations they intend to vend fresh food or is the Authority open to fresh food options for all locations?

Response: The Authority is open to fresh food options at all locations.

24. Question: Will some of the current vending machines be swapped out for a micro market?

Response: The Authority is open to all solutions for each location.

25. Question: Does the Authority currently have any micro markets?

Response: No.

26. Question: Are any of the Authority's vending machines open to the public?

Response: Yes, please see Appendix A of this addendum.

27. Questions: Who is the Authority's current vendor for vending machines?

Response: The Authority's current vendor is RDS Vending and Coffee.

28. Question: Can the Authority confirm how long they have had their current vending machine vendor?

Response: The Authority has had its current vendor for approximately 12 years.

29. Questions: Can we submit questions more than once into the Question Submission Form?

Response: Yes.

30. Questions: If we submit questions on September 2nd, what is the turnaround time to receive a response via addendum?

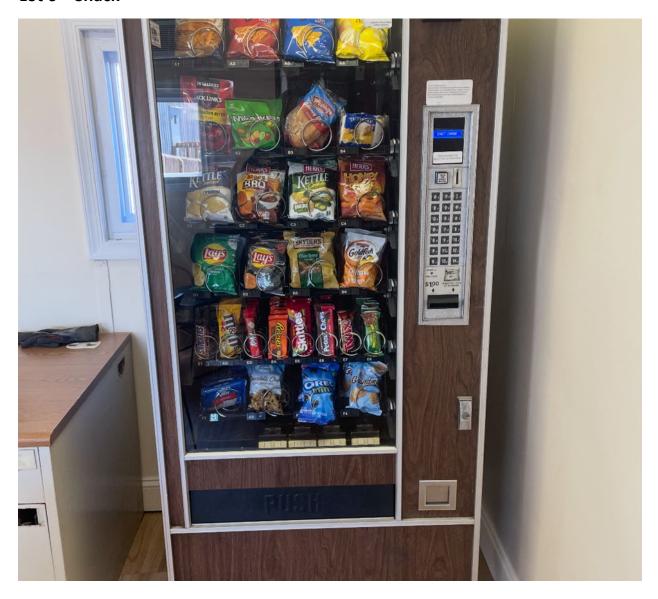

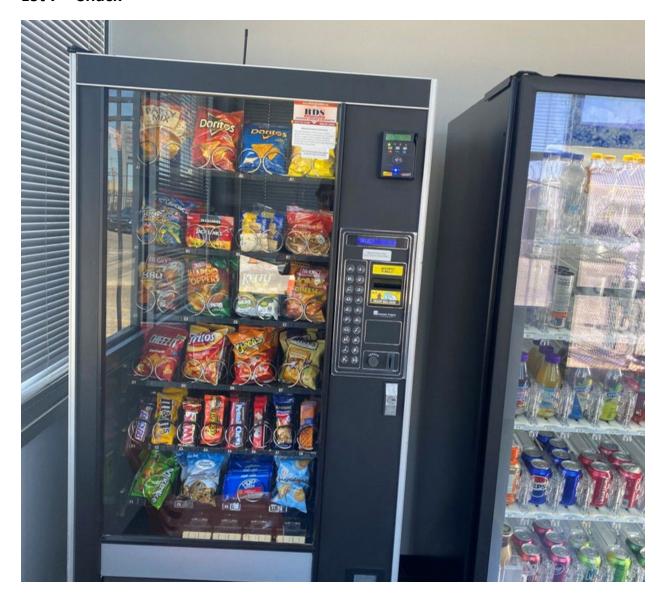
