1. Section E - Fleet Composition of the Work Statement: Section E of the Work Statement has been revised, please see Appendix A of this addendum.

QUESTIONS

1. Question: We provide recalibration services (lane departure warning system, lane keep assist, heads up, display, etc.,) and require it on any vehicle that we replace the windshield on, if it is needed. Can you please advise if the PPA authorizes this type of service and if it would be needed?

Response: As stated in IV-2 section A.5 "the selected Offeror(s) will be responsible for reconnecting any features of the glass being replaced." lane departure warning system, lane keep assist, heads-up display, etc. fall under "features" that the selected Offeror will be required to reconnect.

2. Question: Are you able to advise, on average, how many service calls would be needed on a weekly basis for your fleet of 360 vehicles?

Response: The Authority historically requires one to two service calls per month.

3. Question: A list of vehicles in your fleet that would need servicing is provided in the RFP document; however, it does not list the years of the vehicles. Are you able to give us an idea how old or new these vehicles are, this determines part numbers/cost/pricing/etc.
