**BEFORE PURCHASING A VEHICLE- ALL TAXICABS CANNOT BE OLDER THAN 10 YEARS OLD OR HAVE A 350,000 ODEMETER READING. IT IS IMPORTANT TO REMEMBER THAT AN APPROVED TAXIMETER SYSTEM MUST BE INSTALLED AND MAY NOT BE COMPATIBLE WITH NON-LISTED VEHICLES.**

**TOYOTA RAV-4 - 2017 or newer, with an approved camera system**

**TOYOTA Sienna - purpose-build taxi or MODIFIED ACCESSIBLE and ADA COMPLIANT**

**W.A.V. Taxicabs coming into service must be inspected and comply with 52 Pa. Code § 1017.8**

**\* BEFORE BEING PLACED INTO SERVICE ALL VEHICLES MUST COMPLY WITH THE TAXICAB AND LIMOUSINE REGULATIONS, SECTION § 1017.5, RELATING TO BASIC VEHICLE STANDARDS WITH PARTICULAR ATTENTION TO PASSENGER LEG ROOM, ABILITY TO TRANSPORT A STANDARD WHEELCHAIR STOWED IN THE TRUNK AND H.V.A.C. COMFORT IF A SHIELD IS REQUIRED TO BE INSTALLED.**
